The Motion to Disqualify Russo & Hale LLP by Defendants David Winer and Scripting News, Inc. came on for hearing before the Honorable Joseph Huber on March 7, 2007 at 9:00 a.m. in Department 8. The matter having been submitted, the Court orders as follows:

In the first four causes of action, Russo & Hale LLP is, in effect, representing all of the Userland minority shareholders in a derivative action against Defendant David Winer ("Winer"), the majority shareholder, with regard to claims for breach of fiduciary duty, waste, unjust enrichment, and fraud. However, in the fifth cause of action, Russo & Hale LLP is representing itself in a direct action against Userland and Winer with regard to a claim that Russo & Hale LLP is entitled to a 10% equity interest in Userland and NEWCO.

As was the case in *Apple Computer*. *Inc. v. Superior Court* (2005) 126 Cal.App.4<sup>th</sup> 1253, 1273, we are dealing with more than speculative conflicts and the appearance of impropriety. Russo & Hale LLP has placed itself in a position of divided loyalties by attempting to represent

the minority shareholders on a claim against the majority shareholder while simultaneously representing itself on a separate claim that is adverse to the minority shareholders. This is a direct conflict of interest and a ground for disqualification. Accordingly, Russo & Hale LLP are hereby disqualified from serving as counsel in the derivative causes of action.
